# 2.0 Rules and Regulations

### 2.1 Applicability

The rules and regulations set forth in this section shall be applicable to Colorado intrastate transportation provided by Epic Charter.

### 2.2 Passenger Service and Restrictions

Epic Charter reserves the right to refuse transportation to any person who, in the opinion of a driver in charge of the transportation, is under the influence of alcohol or other drugs, is suffering from a contagious disease, is behaving in a manner considered to be offensive, or presents a risk to himself, herself, other passengers, third parties, or the driver. Such refusal shall not be based on religious, ethnic, or any other discriminatory characteristic prohibited by law.

#### 2.3 Animal Restrictions

Except as allowed by this item, animals/pets shall not be transported. Service animals traveling with their masters will be transported. Service animals shall be under the control of their masters at all times. Epic Charter will not be responsible for loss or injury to these animals, nor for an injury or damage to any person or property caused by the actions of these animals.

#### 2.4 Inclement Weather and Road Conditions

Nothing in this tariff shall require Epic Charter to transport passengers if in the opinion of the driver in charge of transportation, weather, street, road, or highway conditions,

either from the point of origin, destination, or points in between, render operation of the motor vehicle dangerous or impracticable.

# 2.7 Payment Types and Time of Collection

Payment for all fares and charges shall be in U.S. dollars in the form of cash, personal checks, traveler's checks, business checks, or approved credit cards. Receipts will be provided upon request.

### 2.8 Reservation, Cancellations, and Refunds

If a cancellation request for a specific trip or tour is received by Epic Charter at least 24 hours before the departure time, the passenger will not be charged a cancellation fee and any payment will be refunded. If a cancellation request for a specific trip or tour is received by Epic Charter less than 24 hours before the departure time, the passenger will be charged a cancellation fee equal to 100% of the prepayment for the service.

If a passenger has pre-paid for a call-and-demand service and is not at the agreed upon pick-up location at the agreed upon pick-up/departure time, no refund will be issued.

# 2.9 Complaints

Passengers may submit complaints to Epic Charter by U. S. mail, e-mail, or by telephone. Staff of Epic Charter will make an effort to resolve the complaint fairly. If the complainant is not satisfied, he/she may contact the PUC at:

#### 2.10 Claims

Claims for lost, damaged or destroyed articles must be submitted to Epic Charter by U. S. mail, e-mail, or by telephone within seven (7) days of the completion of the transportation during which the damage or loss occurred.

#### 2.11 Liability

Except due to the negligence of the staff of Epic Charter, including the driver in charge of the transportation service, Epic Charter shall not be responsible for a passenger's lost, stolen, damaged or destroyed baggage or other personal property.

Epic Charter will not be liable or responsible for damage to property or injury to passengers that result from the acts of passengers or other third parties.

#### 2.12 Commissions

Epic Charter may pay commissions to travel agents, transportation brokers or other businesses with which it has agreements regarding such commissions.

## 3.0 Rates and Charges

Any charge incurred by Epic Charter or its drivers in their provision of transportation services including but not limited to credit card processing fees, road tolls, bridge tolls, use fees, admission/gate fees and parking fees shall be added to the fare.
